## ISO/IEC 27001 Transition

The deadline for the transition to the updated ISO/IEC 27001:2022 standard is fast approaching. The transition period ends on October 31, 2025. To avoid last-minute stress and potential loss of certification, start the transition process today!

### Are You Ready?

Ensure your organization is prepared to transition smoothly by following this checklist:

- **Conduct a Gap Analysis:** Identify differences between ISO/IEC 27001:2013 and ISO/IEC 27001:2022.
- **Update Risk Assessments:** Align with new requirements and evaluate potential information security risks.
- **Review and Revise Documentation:** Update policies, procedures, and controls to reflect the new standard.
- **Train Your Team:** Ensure staff understand new requirements and their responsibilities.
- **Schedule Your Transition Audit:** Plan ahead to secure your preferred audit date and avoid delays.

Organizations using the R2v3 logo on their websites must ensure it is properly hyperlinked to the SERI website, as required. Failure to comply with this requirement may result in a nonconformance during your next audit. Our auditors have been reminded to remain diligent in verifying compliance with PRO-3 and the SERI License Agreement during audits.

SERI has released a revised Code of Practices (Rev. 2.4) as of February 18, 2025. You can **download a copy of the Code of Practices (COP)**, after registering for/signing SERI's agreement. SERI is giving 90 days for implementation, meaning that the COP should be fully implemented by May 18th, 2025.

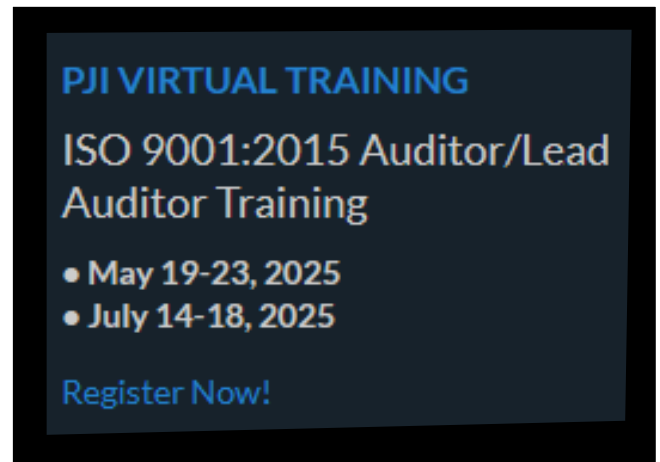
